ACKNOWLEDGEMENT OF RISKS, DANGERS AND OBLIGATIONS

I acknowledge that motorcycle racing is dangerous and that by engaging in the riding of motorcycles as part of the AJS Motorcycle Club of WA INC or by attending the premises of the AJS Motorcycle Club of WA INC I am exposed to certain risks and dangers and I am under certain obligations which risks, dangers and obligations I accept and participate in at my own risk. The risks, dangers and obligations include but are not limited to: -

- (a) I may be injured physically or mentally and may be killed.
- (b) That my property and machinery or equipment may be lost, damaged or destroyed.
- (c) That other riders may ride dangerously or with a lack of skill.
- (d) That the conditions may be hazardous and may vary without warning or predictability.
- (e) That there may be no or inadequate facilities for treatment and transport of me if I am injured.
- (f) That any policy of insurance of or in respect to my life or physical or mental health may be void.

CONTRACT EXCLUDING LIABILITY

In consideration of the acceptance of me as a member of the AJS Motorcycle Club of WA INC I agree to absolve and release from all liability the AJS Motorcycle Club of WA INC, it's members, servants or agents and the authorities which own, occupy or manage the land on which motorcycle racing is to take place, for any injury or damage to myself or my property arising out of participation in or as an observer to motorcycle racing due to any negligent act, breach of duty, default and/or omission on behalf of the AJS Motorcycle Club of WA INC, their members, servants or agents or any part of any of the persons or authorities who own, occupy or manage the land on which the motorcycle racing is to take place. I further acknowledge: -

- (a) That I accept the property as it stands with all or any defects hidden or exposed.
- (b) That I will ride in a manner, which is safe, and with all due care and attention.
- (c) That I am a member of and attend AJS Motorcycle Club of WA INC at my sole risk and responsibility.
